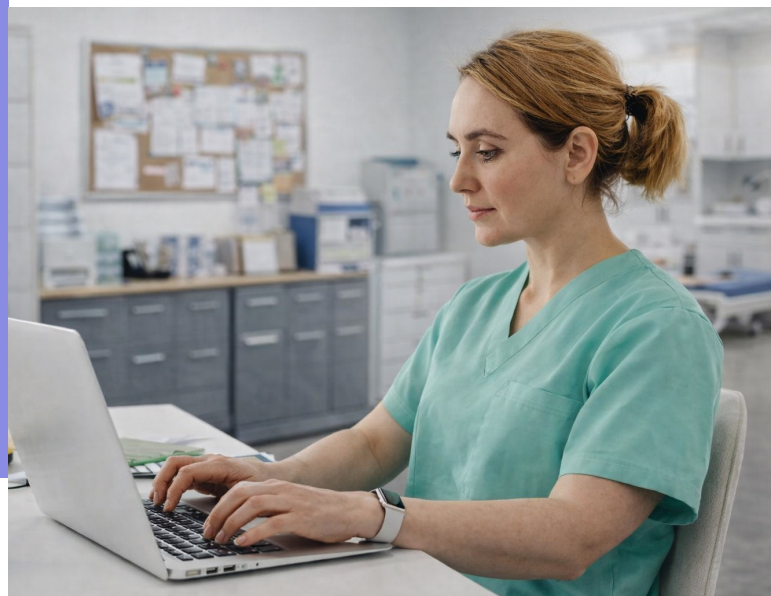


Level 2: TB Case Management

Training Overview

These *Level 2* training materials are designed for TB case managers caring for persons with TB disease.

Throughout the modules, you will be asked to follow patient scenarios, answer questions, and reflect. Please be prepared to take notes and keep track of your reflections.

How to Access the Training

1. Apply through CITC's website. You can find the course listed on the Training page or go directly to the *Level 2* course page.

Note: Learners are admitted on a rolling basis, twice per week.

How to Get Your Certificate of Completion and Nursing Continuing Education Hours

Learners may complete as much or as little of the curriculum as needed. Eligibility for Nursing Continuing Education (CE) hours or a Certificate of Participation depends on the amount of content completed.

Completion for Nursing CE Hours

This training is approved for up to 10.00 Nursing CE hours. To receive 10.00 Nursing CE hours, participants must:

2. Submit a post-training evaluation, and
3. Attend one (1) Live Session via Zoom. (There may be two dates to accommodate varying schedules. If you're unable to attend either session, we regret that no additional dates will be offered for this cohort.)

Completion for Certificate of Participation (no Nursing CE)

1. Completion of all six self-paced modules is not required; learners may take a flexible approach and complete only the content that meets their needs.
2. Live Sessions function as optional "office hours."
3. Participants who do not meet CE requirements will receive a Certificate of Participation.

Module to Complete in Canvas	Estimated Time to Complete	What You Will Learn
The Role of a Case Manager	15-30 minutes	Describe the core responsibilities of a TB case manager and the role of case management in supporting successful TB treatment and public health outcomes.
The Fundamentals of TB Diagnosis	60-75 minutes	- Describe the symptoms of pulmonary and extrapulmonary TB. - Understand the key components of a TB medical evaluation. - Describe the 5 steps in the detection of M. tuberculosis from a clinical specimen. - Explain the role of the TB case manager in ensuring a complete evaluation for the diagnosis of TB disease.
Treatment of Drug-Susceptible Tuberculosis	60-90 minutes	- Identify the recommended regimens and first-line medications for treating DS-TB disease. - Identify common adverse reactions to first-line medications. - Explain activities for monitoring response to treatment. - Identify risk factors for treatment relapse and treatment failure.
Case Management for Drug-Susceptible Tuberculosis	90-120 minutes	- Describe the key steps of TB case management. - Describe various ways a TB case may be reported to the health department. - Describe the components of the initial patient visit. - Identify methods to support TB treatment adherence. - Identify factors associated with increased infectiousness and criteria for determining noninfectiousness. - Identify how to monitor side effects and manage medication changes. - Describe how to coordinate care and monitor response to TB treatment.
Supporting Patients to Complete Treatment	60-75 minutes	- Describe common barriers to completing TB treatment. - Identify social and personal factors that impact TB treatment adherence. - Apply strategies to support adherence and minimize interruptions in TB treatment.
Determining Treatment Completion for Drug-Susceptible TB	90-120 minutes	- State the criteria for determining the duration of treatment for drug-susceptible tuberculosis (DS-TB). - Understand how to count total treatment weeks and doses. - Understand how to manage missed doses and treatment interruptions.
