Training Overview

These *Level 1* training materials are designed for nurses and public health/disease control investigators who are new to TB prevention and care responsibilities. Content covers the foundational concepts necessary for staff to conduct contact investigations and case management for persons with LTBI.

Throughout the modules, you will be asked to follow patient scenarios, answer questions, and reflect. Please be prepared to take notes and keep track of your reflections.

Online Self-Study

Each asynchronous module will take approximately 30-60 minutes to complete. *Level 1* covers the following modules:

4. Diagnosing Latent TB Infection
5. Case Management and Coordination of Latent TB Infection Treatment and Care

You may complete as much or as little of the curriculum, in any order, as needed.

How to Get Your Certificate of Completion and Nursing Continuing Education Hours

Learners may complete as much or as little of the curriculum as needed. Eligibility for Nursing Continuing Education (CE) hours or a Certificate of Participation depends on the amount of content completed.

Completion for Nursing CE Hours

1. Completion of all five self-paced modules is not required; learners may take a flexible approach and complete only the content that meets their needs.
2. Live Sessions function as optional "office hours."
3. Participants who do not meet CE requirements will receive a Certificate of Participation.

Tuberculosis Basics	30-60 minutes	- Describe TB transmission. - Recognize key risk factors for TB exposure, TB infection, and progression from latent TB infection (LTBI) to TB disease. - Explain the difference between LTBI vs. TB disease. - Describe the common signs and symptoms of TB disease. - Describe the basic tests to diagnose LTBI vs. TB disease, and how treatment differs between the two conditions. - Understand the patient experience in being diagnosed and treated for TB disease.
Tuberculosis Contact Investigation Framework and Tools	30-60 minutes	- Describe the essential steps of a TB contact investigation. - Name the criteria used to determine the infectious period for someone with infectious tuberculosis. - Describe what should be assessed to prioritize contacts. - List 3 criteria used to determine when to expand the scope of a TB contact investigation.
Tuberculosis Patient Interview	30-60 minutes	Describe several aspects of the TB patient interview that are essential to TB contact elicitation and referral.
Diagnosing Latent TB Infection	30-60 minutes	- Identify individuals at risk for LTBI and disease progression. - Describe the diagnostic tests for LTBI, including the rationale for choosing each test and how to interpret the results. - Describe the impact of BCG vaccination on TB testing.
Case Management and Coordination of Latent TB Infection Treatment and Care	30-60 minutes	- Understand key steps involved in case management and coordination of LTBI treatment. - Identify the recommended regimens for treating LTBI. - Describe baseline evaluations that should be performed prior to LTBI treatment initiation. - List the common side effects to monitor during LTBI treatment and the criteria for determining when treatment is complete.
